Italy: with Malta, Albania and countries of Eastern Europe;

Austria: with countries of Eastern Europe together with Italy.

The general assistant will take on of the contacts with Bishops who are interested in CA.

B) The Secretariat will try to promote CA in African and Asian countries.

### *III - CONTACTS OF IFCA*

A) With Pontificium Concilium pro Laicis

- to make its own constitution and identity known

- to answer to invitations and to participate to initiatives promoted by Pontificium Concilium pro Laicis.

B) With CIO and all the associations and movements, at an international level.

C) With lay organizations on continental and regional level.

### *IV - IFCA AND NEW EVANGELIZATION*

The New Evangelization is the theme of next general IFCA assembly in Wien.

This theme should be developed also in the bilateral and regional meetings, as a preparation to the above Assembly.

These four aspects ought to be considered:

1 - Situation which the Church lives in each place in relation to the protagonism of lay people in the New Evangelization.

2 - Kind of evangelization requested by the situation.

3 - CA has to work so that the lay people can assume a responsibility more and more mature and adult in the ecclesial community.

4 - Which contribution FIAC can give.
